

KELLOGG'S* BREAKFAST IN _____ CONTEST

OFFICIAL CONTEST RULES

(the "Contest Rules")

THIS CONTEST IS OPEN TO LEGAL RESIDENTS OF BRITISH COLUMBIA, ALBERTA, SASKATCHEWAN, MANITOBA, KENORA DISTRICT OF NORTHWESTERN ONTARIO AND NORTHWEST TERRITORIES ONLY, WHO HAVE REACHED THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE. See below for additional eligibility requirements.

HOW TO ENTER:

1. The **Kellogg's* Breakfast In _____ Contest** (the "**Contest**") commences at 12:00:01 am Eastern Standard Time ("EST") on October 11, 2018 and concludes at 11:59:59 pm EST on November 7, 2018 (the "**Contest Period**"). The time at which the Contest concludes is referred to in these Contest Rules as the "**Contest Closing Time**".
2. To enter, go to a Participating Co-op(s) (as defined in Section 5 below) in British Columbia, Alberta, Saskatchewan, Manitoba, the Kenora District of Northwest Ontario or the Northwest Territories (each, a "**Participating Store**") and purchase any two (2) participating Kellogg's* or Pringles* products (the "**Participating Product(s)**") on the same receipt (each, an "**Eligible Purchase**") from the Participating Store; (ii) next, go to www.cooppromotions.com (the "**Contest Website**") during the Contest Period and follow the on-screen instructions to complete the online registration form with all required information; (iii) upload a photo of the receipt that clearly shows retailer name, date, time, and qualifying purchases; and (iv) click the Submit button to complete your online registration ("**Request**"). Purchase of qualifying Participating Products must be made in a single transaction during the Contest Period, and upload of the receipt must both be completed by November 7, 2018 at 11:59:59 p.m. EST. Acceptable file formats are: .JPG, .JPEG, .PNG, and .GIF. Maximum file size is 4 MB. A receipt may be uploaded only once. By submitting a Request, the participant grants permission to Sponsor or Administrator to notify them via a return email message. Standard data rates apply to participants who choose to participate in the Contest via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

3. **NO PURCHASE NECESSARY:** To obtain an entry into the Contest without purchase, write a unique and original 50-100 word or more essay describing "**Why I Love Kellogg's* or Pringles* Products**", and mail in your essay, in an envelope, along with your first and last name, complete mailing address, telephone number and email address, to: **Kellogg's* Breakfast In _____ Contest**, c/o My Brother Darryl, 20440 Simcoe St., Seagrave, ON, L0C1G0. Only one essay can be mailed per external envelope. Entry must be mailed with sufficient postage and be post-marked by November 7, 2018 and received no later than November 14, 2018.
4. There is no limit to the number of entries allowed, regardless of method of entry.
5. **ELIGIBILITY:**

The Contest is open to legal residents of British Columbia, Alberta, Saskatchewan, Manitoba, **Kenora** District of Northwest Ontario and Northwest Territories only, who have reached the age of majority in their province or territory of residence, excluding (a) employees, directors, officers, representatives and agents of (i) Kellogg Canada Inc. (the "**Sponsor**"), (ii) its advertising and promotional agencies, (iii) participating Retail Co-operatives of Federated Co-operatives Limited

(the “**Participating Co-op(s)**”), Federated Co-operatives Limited and board members and subsidiaries of Federated Co-operatives Limited (iv) any promotional agencies taking part in the implementation of this Contest (the “**Contest Parties**”), and (b) all persons with whom those in (a) are domiciled. An entrant must meet the eligibility criteria set out in these Contest Rules from the time of entry until the time he/she is confirmed a winner (if he/she becomes a winner). Without limiting any other provision of these Contest Rules, an entrant will not be confirmed a winner until the completed and signed Prize Claim Form is received, as set out in paragraph 15 of these Contest Rules (see below for details respecting Prize Claim Form and other Contest requirements).

6. The Sponsor reserves the right to require proof of eligibility, which proof shall be in the form required by the Sponsor.

PRIZES AND ODDS OF WINNING:

7. There is one (1) Grand Prize (the “**Grand Prize**”) and five (5) Secondary Prizes (the “**Secondary Prize(s)**”) available to be won in this Contest.
8. **Grand Prize:** one (1) Grand Prize consisting of one (1) trip for the winner and one (1) guest to any destination in Canada, including economy airfare and accommodations, with an approximate retail value (“**ARV**”) of up to fifteen thousand Canadian Dollars (\$15,000.00 CDN) (“**Grand Prize**”). The Grand Prize will be planned in conjunction with the Sponsor’s designated agent. All aspects of the Grand Prize are at the sole and absolute discretion of the Sponsor. Under no circumstances whatsoever will any difference between the actual and approximate retail values of the Grand Prize be awarded.

Without limiting the generality of the foregoing, the following general conditions apply to the Grand Prize: (i) up to a maximum of five thousand dollars (\$5,000.00 CDN) in spending money can be included as part of the Grand Prize, at the sole and absolute discretion of the Sponsor, provided that the total amount of spending money plus other Grand Prize expenses is less than or equal to the maximum total Grand Prize total ARV of fifteen thousand dollars (\$15,000.00 CDN); (ii) Grand Prize must be accepted as awarded and is not transferable, assignable and/or convertible to cash (except as may be specifically permitted by Sponsor in its sole and absolute discretion); (iii) no substitutions except at Sponsor’s option; (iv) all travel related to the Grand Prize must occur within one (1) year of winner notification (otherwise the Grand Prize may, in the sole and absolute discretion of the Sponsor, be forfeited in its entirety and, if forfeited, nothing will be substituted in its place); (v) the confirmed winner and his/her guest(s) must travel on the same itinerary; (vi) the costs of everything not specifically and expressly stated as included in the Grand Prize may be the sole and absolute responsibility of the confirmed winner and his/her guest, and could include, without limitation: spending money not included in Grand Prize, meals and drinks; gratuities; entertainment; health and travel insurance; transportation for confirmed winner and his/her guest to and from the Canadian airport selected by the Sponsor; additional transportation; baggage and other fees; and items of a personal nature (NOTE: confirmed winner and/or his/her guest may be required to present a valid major credit card in his/her name at the time of hotel check-in to cover any incidental expenses); (vii) if the confirmed winner and/or his/her guest do not utilize any part(s) of the Grand Prize, then any such part(s) not utilized may, in the sole and absolute discretion of the Sponsor, be forfeited in their entirety and, if forfeited, nothing will be substituted in their place; (viii) Sponsor reserves the right at any time to: (a) place reasonable restrictions on the availability or use of the Grand Prize or any component thereof; and (b) substitute the Grand Prize or a component thereof for any reason with a prize or prize component(s) of equal or greater retail value, including, without limitation, but solely at the Sponsor’s sole discretion, a cash award; (ix) all travel arrangements relating to the Grand Prize must be made through the Sponsor or its designated agents; (x) the confirmed Grand Prize winner’s travel companion(s) must: (a) either be of the legal age of majority in his/her province/territory of residence or have the express written consent (in form and substance satisfactory to the Sponsor, in its sole and absolute discretion) to accompany the confirmed

Grand Prize winner on the Grand Prize trip; and (b) sign (and have his/her parent/legal guardian if he/she is under the legal age of majority in his/her jurisdiction of residence) and return the Sponsor's release (by the date indicated on the release form) indicating that he/she waives all recourse against the Released Parties relating to his/her participation in Grand Prize; and (xi) by accepting the Grand Prize, the confirmed winner agrees to waive all recourse against the Released Parties (see Paragraph 25) if the Grand Prize or a component thereof does not prove satisfactory, either in whole or in part (including, without limitation, any travel related thereto).

Secondary Prizes: five (5) Secondary Prizes, each consisting of one (1) one thousand (\$1,000 CDN) CO-OP® Gift Card. Without limiting the generality of the foregoing, the following general conditions apply to each Secondary Prize: (i) Secondary Prize must be accepted as awarded and is not transferable, assignable or convertible to cash (no substitutions except at Sponsor's option); (ii) all costs or expenses related to a Secondary Prize not expressly stated above as being included in the Secondary Prize are the sole responsibility of the winner; (iii) if a winner does not utilize any part(s) of a Secondary Prize, then any such part(s) not utilized will be forfeited in its entirety and nothing will be substituted in their place; (iv) Sponsor reserves the right at any time to substitute any Secondary Prize or a component thereof for any reason with a prize or a prize component of equal or greater value, including without limitation, but solely at the Contest Sponsor's sole discretion, a cash award; and (v) by accepting a Secondary Prize, each winner agrees to waive all recourse against the Released Parties (see Paragraph 25) if the Secondary Prize or a component thereof does not prove satisfactory, either in whole or in part. Gift cards are subject to the terms and conditions of the issuer.

Grand Prize and Secondary Prizes are each a Prize ("**Prize**"), and collectively, Prizes ("**Prizes**").

HOW PRIZES ARE AWARDED

9. A random draw ("**Prize Draw**") to award the Prizes, subject to these Contest Rules (including without limitation the Prize Claim Form and skill-testing question requirements set out below), will occur on November 15, 2018 at 2:00pm EST in Seagrave, Ontario from all eligible entries received by the Contest Closing Time. The Prize Draw will be conducted by an independent judging organization (the "**Contest Management Organization**"). One (1) entry will be randomly drawn in respect of the Grand Prize and five (5) entries will be drawn in respect of the Secondary Prizes that are available to be won.
10. If your entry is selected in the Prize Draw as a potential winner of a Prize, you will be notified by phone call to the telephone number appearing on the Request form to confirm eligibility.
11. Prior to being declared a winner, a Prize Claim Form will be mailed to you for completion (see below for details regarding the Prize Claim Form and the skill-testing question requirement).
12. If a selected entrant cannot be contacted by phone within seven (7) days of the draw, or if a selected entrant is ineligible or does not comply with the Contest Rules, such entrant may, at the discretion of the Sponsor, have forfeited his/her opportunity to win a prize and an alternate entrant will be selected by random draw to win, subject to these Contest Rules.

SKILL-TESTING QUESTION

13. 17. The Sponsor respects your privacy. By entering the Contest, you consent to the collection, use and disclosure of your personal information. You may check the box on the Request form to opt in to receive marketing communications from Federated Co-operatives Limited. If consent is actively and voluntarily given at the time of entry to provide you with the latest email offers and communications from Co-op, then Federated Co-operatives Limited will use your personal information for that purpose. Otherwise, subject to paragraph 18 personal information provided on the Request form and provided in connection with the Contest is being and will be collected, used and disclosed by the Sponsor and/or by third-party service providers on behalf of the Sponsor (including the Contest Management Organization), only for purposes of administering and conducting this Contest (including determining eligibility), including awarding and delivering the Prize (collectively, the "**Purposes**"), and for no other purpose. For a copy of our Privacy Policy, please visit www.kelloggs.ca.

In connection with the Purposes, your information may be processed and stored in one or more jurisdictions outside Canada (which may include the United States), and may be subject to access by regulatory authorities in those jurisdictions.

18. If an entrant becomes a winner of this Contest, his/her name, the fact that he/she is a winner of this Contest, his/her voice/statements and/or any photograph/likeness/video of him/her, may be used, without notice or compensation, in any subsequent publicity or advertising by or on behalf of the Sponsor relating to this Contest or any similar contests that may be conducted in the future by or on behalf of the Sponsor.
19. No communications will be entered into except with potential prize claimants.

GENERAL

20. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different mailing addresses, identities, or any other methods will void that participant's entries and that participant may be disqualified.
21. All decisions in all matters relating to this Contest shall be made in the sole discretion of the Contest Management Organization and/or the Sponsor and all such decisions are final and binding on all entrants.

22. In the event of a dispute as to whose entry a potential winning entry is, the potential winner will be the person identified on the potential winning Request form as the entrant.
23. Proof of sending (regardless of method of sending) is not proof of receipt by the Sponsor, its advertising or promotional agency or the Contest Management Organization.
24. Persons eligible to win the prizes in this Contest may not transfer such prizes or substitute such prizes for cash or otherwise and must accept such prizes as awarded. The Sponsor reserves the right in its absolute discretion to make substitutions of equivalent kind or value in the event of the unavailability of all or part of any prize for any reason whatsoever.
25. Except to the extent prohibited by applicable legislation, each entrant: (a) releases the Sponsor, the Contest Management Organization, its advertising and promotional agencies, Federated Co-operatives Limited, member Retail Co-operatives of Federated Co-operatives Limited, and their affiliates and subsidiaries (including their respective successors and assigns), and all of their respective employees, directors, officers, agents and representatives (collectively, the "**Released Parties**") from and against any and all claims and liability (including costs and expenses related thereto) in any way relating to or arising in connection with the Contest, and (b) agrees not to make any claim against any of the Released Parties, or any claim against any third party which may result in a claim against any of the Released Parties, in respect of any matter in any way relating to or arising in connection with the Contest. Without limiting the generality of the foregoing and except to the extent prohibited by applicable legislation, each entrant agrees that the Released Parties are not responsible for: (a) lost, stolen, late, damaged, destroyed, illegible, incomplete, improperly completed, misdirected or postage-due correspondence (including e-mail transmissions), Contest entries, Prize Claim Forms, as applicable; (b) any other difficulties of whatever nature in the conduct and administration of the Contest; and (c) any injury or damage to an entrant or any other person or other property in any way relating to or arising in connection with participating in this Contest.
26. The Sponsor reserves the right to modify, cancel, suspend and/or terminate this Contest at any time and for any reason, without notice. In the event of Contest cancellation, any remaining prizes still to be won will, in the Sponsor's sole discretion, be deemed expired and void and will be ineligible for Contest play, and, without limiting any other provision of these Contest Rules, the Released Parties shall not have any further liability with respect thereto.
27. The Sponsor may, in its sole discretion, and without notice, terminate the right of any participant in the Contest to participate in the Contest.
28. This Contest is subject to all applicable federal, provincial and municipal laws and regulations. Any dispute shall be adjudicated in the courts sitting in Toronto, Ontario.
29. These Contest Rules are the complete contest rules and form the complete agreement between the Sponsor and Contest participants. In the event that these Official Contest Rules conflict with any other contest-related material, including any condensed versions of these rules, these Official Contest Rules shall govern and control.
